## Non-Disclosure Agreement

This Non-Disclosure Agreement (this "Agreement") is made as of the \_\_\_\_ day of \_\_\_\_\_, 2008 by and between PolicroM, Inc. Technology Corporation, having a principal place of business at 2440 Don Reid Drive, Suite 100, Ottawa, Ontario, K1H-1E1 ("PolicroM, Inc.") and \_\_\_\_\_ having a principal place of business at \_\_\_\_\_ "Reseller/Dealer").

In the course of dealings between PolicroM, Inc. and Reseller/Dealer, either party may learn or receive from the other party "Information", as that term is later defined in this Agreement. Reseller/Dealer and PolicroM, Inc. desire to establish and set forth their obligations with respect to this information. In consideration of the foregoing, Reseller/Dealer and PolicroM, Inc. agree as follows:

1. The term "Information" shall mean any and all information, data, know-how and documentation which either party learns or receives from the other party, except that which either party can establish: (1) was, on the date of this Agreement, generally known to the public; or (2) became generally known to the public after the date of this Agreement other than as a result of the act or omission of either party or any of either parties' directors, officers, partners, employees, agents, representatives or contractors; or (3) was contained in documents rightfully known to either party prior to either party learning or receiving same from the other party; or (4) was disclosed by the other party to third parties generally without restriction on use and disclosure; or (5) either party lawfully received from a third party without that third party's breach of agreement or obligations of trust.
2. Both parties consider all Information to be proprietary to each party. All Information shall at all times, and throughout the world, remain the property of each party, exclusively, and all applicable rights in patents, copyrights and trade secrets shall remain with each party, exclusively. Each party shall not permit any person (including but not limited to directors, officers, partners, employees, agents, representatives and contractors) to reproduce or copy any portion of the Information.
3. Neither party shall directly or indirectly use any of the information for any purpose, except to the extent necessary for either party to perform their contractual obligations to each other.
4. Neither party shall disclose, or permit access to, any portion of the Information to any person except if; (1) such person is an employee of either party and has an absolute need to know the Information for either party to perform their contractual obligations to the other party; and (2) such person is legally bound by a written contract to comply with the provisions of this Agreement.

5. Both parties shall indemnify the other party against all losses and expensed incurred by the other (including but not limited to reasonable counsel fees) with result from the breach of any portion of this Agreement by any director, officer, partner, employee, agent representative or contractor of either party.

6. This Agreement shall be effective as of the date first written above and shall continue in effect at least for five years, and thereafter until ninety days after either party receives from the other party written notice of termination; however, this agreement learned or received from each other prior to the date of termination. Immediately after termination of this Agreement both parties shall return all Information in tangible form to each other.

7. This Agreement is the complete and exclusive statement of the agreement between the parties, and supersedes all prior written and oral communications and agreements relating to the subject matter hereof. No modification, termination, extension, renewal or waiver of any provision of this Agreement shall be effective unless in writing and signed by authorized representative of each party.
